### ARIZONA EASEMENTS AND RIGHTS OF WAY (7 Hours CE)

This program, which is tailored to Arizona statutes and case law, is designed to help surveyors and right of way professionals understand the various types of easements and their elements and nature - both written and unwritten. Many surveyors right of way professionals deal with writing and interpreting easements and right of way descriptions virtually every day when performing or reviewing boundary and Land Title Surveys, and when working for developers, utility companies and governmental entities. It is important that they be well-versed in what easements and rights of way are, how they differ from other similar instruments, how they are created and terminated, and in the broad variety and characteristics of easements. This course will provide a good foundation for understanding the myriad aspects of easements and rights of way.

Gary Kent is in his 35th year with The Schneider Corporation, a land surveying, GIS and consulting engineering firm based in Indianapolis and with offices in North Carolina, Texas and Iowa. He is registered to practice as a professional surveyor in Indiana and Michigan. Gary has been chair of the committee on ALTA/NSPS Standards for NSPS and liaison to NSPS for the American Land Title Association since 1995. A member of the adjunct faculty for Purdue University from 1999-2006, Gary taught Boundary Law, Legal Descriptions, Property Surveying and Land Survey Systems and was awarded "Outstanding Associate Faculty" and "Excellence in Teaching" awards for his efforts. He has served on the Indiana State Board of Registration for Professional Surveyors since 2004 and is currently chairman. Gary is frequently called as an expert witness in cases involving boundaries, easements and land surveying practice. He regularly presents programs across the country on surveying and title topics, and he also writes a column for The American Surveyor magazine.
